

**October 2025 Applicant Guidelines for Ph.D. Program  
of the Graduate School of Medical and Dental Sciences  
(Oral Life Science Program Course)  
Niigata University  
(For the 2<sup>nd</sup> Call for Application)**

The Graduate School of Medical and Dental Sciences (The Course of Oral Life Science Program) invites applicants for admission to the doctor's program for the academic year October 2025, in accordance with these guidelines.

**1 , Number of Students to be Admitted**

**2 , Application Qualifications**

Foreign students must vouch for their intention to enter the course and satisfy one of the following conditions ;

- (1) Persons who have completed, or will complete 18 years of academic education (The last specialized course being Medicine, Dentistry, Pharmaceutical Sciences or Veterinary Medicine) in a foreign country, by 30<sup>th</sup> September, 2025.
  - (2) Persons who are recognized by our Graduate School as having equal to or higher academic ability than persons who have completed a course of Medicine or Dentistry or in a clinical field that develop practical abilities in Pharmaceutical Sciences or Veterinary Medicine of a university by eligibility judgement and who will be 24 years of age by 30<sup>th</sup> September, 2025.
  - (3) Persons who have completed studies longer than 5 years of the course (Medicine, Dentistry, Pharmaceutical Sciences or Veterinary Medicine) in a foreign country and have obtained or will obtain the degree of Bachelor of Science by 30<sup>th</sup> September, 2025.
- (Note) : The Eligibility Judgement is carried out before entrance examination. Please refer to Item 3(Judgement of Application Qualifications).

**3 , Judgement of Eligibility**

Applicants who apply for admission are requested to submit the following documents for Judgement of Application Qualifications.

⑧ Registration card or passport copy	Submit a copy of applicant's registration card. However, if applicants do not have a registration card, please submit a passport

Successful applicants will be subsequently informed of entry procedures to Japan.

## **9, Entrance Procedures**

Successful applicants are requested to go through entrance procedures between 24<sup>th</sup> (Wed.) and 25<sup>th</sup> (Thu.) September, 2025.

Details of entrance procedures will be informed at a later date.

(Note) : Do not pay admission fees when applying for admission fee exemption.

## **10, Tuition fee**

(Note 1) : Successful applicants will pay tuition fee from their bank account after enrollment.

(Note 2) : If the tuition fee is revised during the school year, the new fee will apply from the time of revision.

(Note 3) : Further details to be given at a later date.

## **11, Others**

We will not allow any changes to application documents once submitted.

Submitted documents and examination fee once paid are not to be returned to applicants for any reason. However, if applicants do not submit application documents within the application period after paying the examination fee, we will return the paid fee (¥30,000) to applicants. ## **12, Confidentiality of individual information used for admission procedures**

(1) Any name, an address which becomes known when applying, and other individual information are used to do ①the research in the admission procedure (application processing and selection execution), ②announcements of test results, ③investigation, research, and analysis in method of admission procedure, and ④business that accompanies these.

(2) Individual information on the examination result used for the admission procedure is used to carry out the investigation, the research, and the analysis in the course of the admission procedure etc.

(3) Following successful results of the examination, individual information and the entrance exam results which become known when applying in the entrance procedures (admission fee and tuition, etc.), the school affairs relation (school register and study guidance, etc.) and the student support entities (health care and scholarship application, etc.).

Moreover, names of successful candidates and addresses might be used among individual information to reports from the alumni association and the supporters' association of this course of instruction.
